2. Board Application. Rita Drymon applied for the vacant seat on the library board to finish out that term. Moved by Davis, second by Carnahan to recommend the appointment of Rita Drymon to the library board. All ayes, one absent, one seat vacant. Motion carried.
3. Weppler Donation. Troy and Becky Weppler have donated \$10,000 to the library. A discussion was held as to our options of where the money should be placed to get the best

use out of the donation. Moved by Allsup, second by Carnahan to place the \$10,000 in the library savings CD at Linn Area Credit Union. All ayes, one absent, one seat vacant. Motion carried.

Trustees Comments:

Davis explained that the city is beginning to work on the CIP for the city and wants the library to participate in this process along with them. Suggested that this be on a future agenda to begin the process.

Also, Davis told about meeting Bob from Marion who comes to our library instead of Marion and told of the praise he had for our staff and our library.
